General Conduct

Volunteers will consistently behave and act in a way that promotes the positive, truthful, constructive and respectful values fostered by Wakehurst's Independent, to include showing integrity, respect, collaboration and compassion. In doing so, volunteers shall always:

- promote Wakehurst's Independent activities, policies, identity and its candidate and volunteers in a positive and constructive manner, for example on social media or when talking about Wakehurst's Independent;
- act in a way that does not bring disrepute to Wakehurst's Independent;
- be prepared, organised and respectful of others' time;
- use non-discriminatory or non-judgemental language when communicating with others;
- respect others' different points of view and beliefs by being courteous, and not talking negatively to others;
- respect others' boundaries that they may have, for example not wanting to engage in discussion or be involved, or need for social distancing as a Covid protocol;
- maintain confidentiality of others including not disclosing personal information or contact details of others except where it is mandatory or appropriate;
- use any communication devices or platforms provided by Wakehurst's Independent in a respectful manner;
- use electronic resources (for example social media, email and phone) to communicate in ways that are safe, legal, truthful, considerate and positive;
- disclose, and take steps to avoid, any conflicts of interest whether real or apparent.

Safety

As a volunteer you have a Duty of Care under the Safety Act to undertake activities in a way that is:

- safe, by observing the rules and any safety procedures provided;
- following any direction provided by event organisers or designated helpers;
- not putting others at risk of injury or incident, and where a risk or incident is identified, to stop as soon as practicable when identified and report the (near-)incident to your leader
